Objective 1.3: Coordinate implementation and planning of current and ongoing park and trail plans. (Park and Trail Development)

Objective 1.4: Increase the number of individual trail and park plans to create a regional park, Greenway and Blueway system in the Tri-Cities Region. (Park & Trail Development)

Objective 1.5: Create a Park & Trail operations and maintenance plan. (Park and Trail Sustainability)

FOLAR will play a leading role in advocacy, communication, marketing, and philanthropy for the Appomattox River Blueway-Greenway.


Objective 3.1: Develop advocacy positions that strengthen and advance FOLAR's mission.
